PROPOSED RESOLUTION

EARMARKS

<u>Whereas</u>: The powers of the U.S. Congress are recognized and listed in Article 1, Section 8 of the U.S. Constitution, and

<u>Whereas</u>: An "earmark" may be defined as a legislative (especially congressional) provision that directs approved funds to be spent on specific projects, or that directs specific exemptions from taxes or mandated fees, and

Whereas: Earmarks are also known as "amendments,' and

<u>Whereas</u>: Earmarks are commonly used to leverage votes for a particular piece of legislation, and

<u>Whereas</u>: Many earmarks bear no relationship to the core subject of the legislation for which attached, and

<u>Whereas</u>: Earmarks have proven to be a cause of increased and, sometimes, unfair and/or unnecessary costs to the taxpayer (aka "pork barrel," i.e., "the bridge to nowhere'), and

<u>Whereas</u>: Proposed legislation should merit approval by standing alone without "buying" votes using the "earmark" vehicle,

<u>Now be it therefore Resolved</u>: By the Barrow County Republican Party that we, as a people, a state, and a nation, demand in the spirit of fiscal responsibility, congressional accountability, and common decency that Congress pass legislation to outlaw earmarks.

"Sears, the iconic retailer, has long been the pride of the Chicago suburb of Hoffman Estates, Ill. But so misgoverned is the political incubator of Barack Obama, Rahm Emanuel, and Daleys various and sundry (who, like the poor, shall always be with us) that Sears may close up shop and move its headquarters. Where? Don't let the National Labor Relations Board hear about it . . . but South Carolina is in the running, as is Texas. A firm with \$40 billion in revenues and 280,000 employees, Sears is uneager to suffer under the jacked-up personal and corporate income tax rates recently imposed on Illinois by its spendthrift Democratic leadership.
