Please mark **MARCH 9**, **2013** (Saturday) on your calendars and appointment books. That is the date for our 2013 Precinct Meetings and County Convention at 9:00 AM and 10:00 AM, respectively. We will be electing officers for 2013-2015, and selecting delegates and alternates to the 2013 District and State Conventions. I will be making my recommendations to the **March 9** Nominations Committee based on volunteer service over the past 2 years and likelihood of attending the district and state conventions. We will also be forming the new County Committee for 2013-2015 (voting members).

In order to become a voting member for 2013-2015, our rules require 3 things: (1) Advanced membership (or greater), (2) being a delegate to the County Convention [March 9, 2013], and (3) notifying the new Chairman (2013-2015) that you want to be a voting member (for 2013-2015)[note – some County Convention delegates do not want to be voting members for various reasons]. Your presence on March 9 is critical, if you want to be a voting member for the new 2-year cycle!

Current GAGOP Chair Sue Everhart's final tern ends at the May State Convention. At least two candidates are running to take her place, and they are scheduled to address our group in February and March. (Candidates for other GAGOP offices may also be given speaking time, if we are able to do that.) Please plan to attend our monthly meetings!

Our next regular monthly meeting will be Monday, **January 21, 2013** at 7:30 PM in the Winder Woman's Club. Let's get off to a great start in 2013! We will issue and discuss the call for the convention process in 2013, explain consideration for becoming a delegate or alternate to the District and State Conventions, begin consideration for serving on our work committees during the next 2 years, and go over basics of what our party faces. We will also see a DVD presentation entitled "The Conservatives." It was sent to us from the Young America's Foundation. #### ABBREVIATED CALL FOR THE BARROW COUNTY REPUBLICAN PARTY ELECTION DISTRICT (PRECINCT) MASS <u>MEETINGS</u>

Pursuant to the Call of the Georgia Republican State Executive Committee for Precinct, Rule 9.2 District, County Congressional District, and State Mass Meetings and Conventions, the Barrow County Republican Committee hereby makes and issues this, Official Call, to all legal and qualified voters of Barrow County, Georgia, who are in accord with the principles of the Republican Party, believe in its declaration of policies and are in sympathy with its aims and purposes, to unite under this Call in the selection of Delegates and Alternates to the Barrow County Convention to be held pursuant to this Call. There shall be Election District (Precinct) Mass Meetings on March 9, 2013 at 9:00 o'clock A.M. at 354 E. Broad St., Winder, Georgia, at the Winder Lions Club, which shall elect Delegates and Alternates to the County Convention to be held on March 9, 2013, at same location. Registration begins at 8:00 o'clock A.M. on March 9, 2013. Anyone arriving after 9:00 o'clock A.M. will not be allowed to participate.

#### **COUNTY CONVENTION**

The Barrow County Convention is hereby called to convene at 354 E. Broad St., Winder, Georgia, at the Winder Lions Club on Saturday, **March 9, 2013**, at 10:00 o'clock A.M., for the purpose of electing Delegates and Alternates to the Republican Tenth U.S. Congressional District and State Conventions. Party officers for 2013-2015 will also be elected. Only those Delegates and Alternates elected in the respective Election District (Precinct) Mass Meetings held on **March 9, 2013**, shall be entitled to participate. The Convention itself shall be open to the public.

#### <u>WHAT TO EXPECT AT THE</u> 2013 PRECINCT MEETINGS AND <u>COUNTY CONVENTION</u>

Many of our newer members may not be aware of the significance of the upcoming Precinct Mass Meetings and County Convention set for Saturday, March 9, 2013, at the Winder LIONS Club, 354 E. Broad St., Winder (NEW LOCATION THIS YEAR). The following is information to explain what will be happening on this important date.

Temporary Precinct Meeting Chairpersons will be appointed by the current Barrow GOP Chairman Ken Young. At 9:00 AM on **March 9**, these people will call the 16 individual precinct meetings to order. All participants at these meetings must be duly registered in accordance with State Republican Party rules and Georgia State Election Code. The first order of precinct meeting business is to elect new Precinct Chairpersons for 2013-2015 (and other Precinct officers, if desired by the precinct meeting participants). The new Precinct Chairperson will conduct the rest of the precinct meeting. Each precinct meeting will then elect Delegates and Alternates to the 2013 Barrow County Republican Convention. All Delegates will receive name tags for Convention usage. When all of the elections are completed, the paperwork (in triplicate) will be processed and routed to the appropriate local Party representatives. Other precinct business may take place at this meeting. It will be a good time to get acquainted with other Republicans in your precinct, and plans for future precinct work can be discussed.

At 10:00 AM on **March 9**, the current local Party Chairman Ken young (serving as Temporary Convention Chairman) will call the 2013 County Convention to order. After the Pledge of Allegiance, Invocation, Presentation of the State Call, and Introduction of Elected Officials, the Convention will elect the 2013 Permanent Convention Chairperson and Permanent Convention Secretary. Convention committees will then be dismissed to conduct their work (Credentials, Nominations, Rules). During this time, there may be announcements and speeches in the convention hall.

After the Convention committees return and report, the 2013-2015 Barrow County Republican officers will be elected. These include County Chairperson, First Vice-Chairperson, Second Vice-Chairperson, Secretary, Treasurer, and Assistant Treasurer. The Convention will then elect Delegates and Alternates to the 10<sup>th</sup> U.S. Congressional District Republican Convention to be held on Saturday, **April 20, 2013** (likely in Greensboro, Georgia). Delegates and Alternates will also be elected to the State Republican Convention to be held on Friday and Saturday, **May 17-18, 2013**, in Athens, Georgia. Those who qualify and desire will also form the new County Committee (voting members) for 2013-2015.

Your participation in the 2013 Precinct Mass Meetings will strengthen the Barrow County Republican Party. With your help, we have made a major impact. Headed for **November 2014**, the next election cycle has begun.

#### AN EXPLANATION

There should be a delicate balance between nominees/officials and their political Party. It is a team concept which leads to success. If an official does not maintain a minimum level of support to the Party, then the Party likely will not be excited about his or her re-election efforts. If a Party places undue demands on an official, then problems can develop as well.

Too many of our elected representatives years ago paid memberships at qualifying, only to drop out of any Party support upon taking office. In many cases, those officials would not have been elected without our Party label and election support.

As a Party, we have maintained our part of the delicate balance. THE ONLY DEMAND WE HAVE EVER PLACED ON OUR ELECTED OFFICIALS IS THAT THEY DO THEIR VERY BEST WHILE REPRESENTING THE PEOPLE THEY REPRESENT. As a Party, we have not pushed agendas, other than the principles of our Party platform (lower taxes, less and limited government, equal opportunity for all citizens, etc.). We do communicate our positions to our officials just as other groups and constituents.

To expect our Republican officials to support us with yearly memberships is not asking too much. From our perspective, in getting elected WITH OUR POLITICAL LABEL, they get far more from us in return.

If an incumbent or challenger dislikes the above position, they are encouraged to run as nominees of other Parties or as Independents.

# THE WAY FORWARD FOR THE REPUBLICAN PARTY

They lose and immediately the chorus begins. Republicans must change or die. A rump party of white America, it must adapt to evolving demographics or forever be the minority.

The only part of this that is even partially true regards Hispanics. They should be a natural Republican constituency: striving immigrant community, religious, Catholic, familyoriented, and socially conservative (on abortion, for example).

The principal reason they go Democratic is the issue of illegal immigrants. In securing the Republican nomination, Mitt Romney made the strategic error of (unnecessarily) going to the right of rick Perry. Romney could never successfully tack back.

For the party in general, however, the problem is hardly structural. It requires but a single policy change: Border fence plus amnesty. Yes, amnesty. Use the word. Shock and awe – full legal normalization (just short of citizenship) in return for full border enforcement.

I've always been of the "enforcement first" school, with the subsequent promise of legalization. I still think it's the better policy. But many Hispanics fear that there will be nothing beyond enforcement. So, promise amnesty right up front. Secure the border with *guaranteed* legalization to follow on the day the four border state governors affirm that illegal immigration has slowed to a trickle.

Imagine Marco Rubio advancing such a policy on the road to 2016. It would transform the landscape. He'd win the Hispanic vote. Yes, win it. A problem fixable with a single policy initiative is not structural. It is solvable.

The other part of the current lament is that the Republican Party consistently trails among blacks, young people and (unmarried) women. (Republicans are plus-7 among married women.) But this is not for reasons of culture, identity or even affinity. It is because these constituencies tend to be more politically liberal – and Republicans are the conservative party.

The country doesn't need two liberal parties. Yes, Republicans need to weed out candidates who talk like morons about rape. But this doesn't mean the country needs two pro-choice parties either. In fact, more women are pro-life than are prochoice. The problem here for Republicans is not policy but delicacy – speaking about culturally sensitive and philosophically complex issues with reflection and prudence.

Additionally, warn the doomsayers, Republicans must change not just ethnically but ideologically. Back to the center. Moderation above all!

More nonsense. Tuesday's exit polls showed that by an eightpoint margin (51-43), Americans believe that government does too much. And Republicans are the party of smaller government. Moreover, onrushing economic exigencies – crushing debt, unsustainable entitlements – will make the argument for smaller government increasingly unassailable.

So why give up? Republicans lost the election not because they advanced a bad argument but because they advanced a good argument not well enough. Romney ran a solid campaign, but he is by nature a Northeastern moderate. He sincerely adopted the new conservatism but still spoke it as a second language.

Behind him, the party has an extraordinarily strong bench. In Congress – Paul Ryan, Marco Rubio, Kelly Ayotte, (the incoming) Ted Cruz and others. And the governors – Bobby Jindal, Scott Walker, Nikki Haley, plus former governor Jeb Bush and the soon retiring Mitch Daniels. (Chris Christie is currently in rehab.)

There may not be a Reagan among them, but this generation of rising leaders is philosophically rooted and politically fluent in the new constitutional conservatism.

Ignore the trimmers. There's no need for radical change. The other party thinks it owns the demographic future – counter that in one stroke by fixing the Latino problem. Do not, however, abandon the party's philosophical anchor. In a world where European social democracy is imploding before our eyes, the party of smaller, more modernized government owns the ideological future.

Romney is a good man who made the best argument he could, and nearly won. He would have made a superb chief executive, but he (Like the Clinton machine) could not match Barack Obama in the darker arts of public persuasion.

The answer to Romney's failure is not retreat, not aping the Democrats' patchwork pandering. It is to make the case for unrestrained, rationalized and reformed government in stark contradistinction to Obama's increasingly unsustainable bigspending, big-government paternalism.

Republicans: No whimpering. No whining. No reinvention when none is needed. Do conservatism, but do it better. There's a whole generation of leaders ready to do just that.
