I'm constantly hearing these days that our government is becoming progressively (pun intended) more socialist. I have a different take. I believe the biggest threat to our republic is not socialism but neo-fascism.

I know calling people "fascists" isn't very nice, so let me take a few moments to explain what I mean before telling you why I believe neo-fascism is the greater danger.

First of all, contrary to what we've been told, fascism is not a philosophy of the extreme right. It's actually a form of statism, which makes it by definition a leftist ideology.

Remember, "Nazi" was short for "National Socialists." Mussolini, who was more intellectually invested in fascism than Hitler, called it the "third way," by which he meant a third leftwing alternative to socialism and communism.

Under communism, the government owns the means of production. Socialists allow capital to remain ostensibly in private hands then "redistribute" via confiscatory taxes. Fascism incorporates elements of both, but instead of owning seeks merely to control. Thus "private" enterprise can't operate without dispensation from the ruling class.

In other words, fascism creates a kind of unholy alliance between corporations and government, in which the former strive shamelessly to curry favor and the latter picks economic winners and losers.

Post-World War II, after the collapse of fascist regimes in Germany and Italy, a somewhat watered-down version of their economic model remained in vogue throughout Europe. Historians now refer to it as "corporatism," but I think we could just as easily label it "neo-fascism" or "fascism light."

What has that got to do with America in 2015? Just think about what's been going on in this country for the last decade, from the automotive industry bailout to federal funding of dubious "green initiatives" to the testing-industry-driven rush to Common Core to the collusion between the government and the insurance industry to drive up rates, also known as Obamacare.

Consider this, too: the gap between haves and have-nots in this country is wider now than it's been in nearly 30 years, with much of that discrepancy occurring just since 2009, according to a recent study by the Economic Policy Institute.

If our current administration is really made up of redistributionists, then either they're the worst redistributionists in history or - more likely - they're intentionally redistributing upwards. That's what we sometimes refer to as "crony capitalism," but we ought to be calling it by its true name: corporatism, a.k.a fascism light.

The real danger of this ideology is that it crosses party lines. I'm not going to name names here, but believe me when I say there are dyed-in-the-wool corporatists in both parties. Together, they run Washington.

The only solution is to elect candidates, regardless of party, who support a true free enterprise system, one that does not favor any particular group, corporation or industry and in which everyone has an equal opportunity to prosper.

#### LEGAL POT BRINGS PROBLEMS

Colorado and Washington are one year into their experiments with marijuana legalization.
