POST-ELECTION DARK CLOUDS ARE GATHERING

After suffering through a Great Recession which rocked most citizens at a level they had never experienced, we've "enjoyed" a prolonged "recovery" of our nation's economy and a long run on the bulls on Wall Street. As we know, economies typically run in cycles so it doesn't take a genius to predict that there will be, in the future, a downturn in our economy and/or financial markets.

The real challenge is predicting when and just how hard the next round of economic hard times might be and for whom.

The answer? It will likely be soon after the November election ends – and pretty hard for all.

That is a bold statement, but I can back it up with a combination of historical patterns as well as with a bit of simple logic.

In recent presidential election cycles the economy has generally been relatively strong. For example, Bill Clinton rode a wave of a rebounding economy in 1996 and handed the Democratic mantle to Al Gore, who lost by "a chad" in another strong year for our economy. After a crash of the web-based economy and 9/11, the nation's financial footing had rebounded again as George W. Bush won his second term in office. Fast forward to 2008. The economy was hardly an issue that year – until the contest reached its final weeks and a financial house of cards began to collapse at a rapid rate.

Recent history would suggest that during modern presidential election years both the economy and financials hang in there with all of their might, usually past the actual Election Day.

In some instances, both the economy and markets have doubled down with growth and expansion in years after a presidential contest. It appears highly problematic as to whether such will be the case after the 2016 contest.

That leads to the anecdotal evidence. In 2006, while still writing my national column for Creators Syndicate and returning from a speech in Florida, I noted empty high-rise buildings in Miami. They were all lighted with similar round bulbs designed to give the appearance of a vibrant skyline. The housing bubble was starting to burst, but Wall Street and Washington, D.C. were clueless. Fast forward to 2016. Miami has been on another tear of development geared to high end buyers. But in the last year one of the nation's hottest markets is now cold as ice. There is a backlog of condominiums for sale in that market that is in the thousands and growing. Meanwhile development rages in other areas of Florida with a massive high end plan on the table in Tampa and a true skyscraper residential tower set for an already "on fire" downtown Saint Petersburg.

That is very much the pattern Tampa/St. Pete took in 2006 and which left the area with spanking new condos built for million

dollar sales but purchased at bargain basement prices after the home mortgage world and derivatives brought the nation to its knees in late 2008.

Usually these type of meltdowns start in the hot state of Florida and march to the north. With cranes dotting every section of Atlanta such a slowdown would not be without precedent. But even a meltdown of huge magnitude would likely leave Atlanta and Georgia in a stronger position than in the recent slowdowns. Our institutions, from Sea Island to Sun-Trust are all stronger than they were when the Great Recession hit and are stronger than similar institutions in other states.

However, be prepared for chop[y waters after November. Money around the world is too cheap and government debt is far too high. We are quickly reaching a point at which the baby Boomer generation will be retiring on droves, claiming more benefits to be supported by a smaller workforce.

That matters as corporate revenues around the world remain stagnant or in decline. The combination of these could result in a severe reversal in our financial markets and slowdown in our global economy in the post-presidential election year, regardless of who wins the presidency.

Last fall, Clinton's campaign website proclaimed that "every survivor of sexual assault" has "the right to be believed." This spring, shortly after Juanita Broaddrick reiterated her 38-yearold rape accusation against Bill Clinton on Twitter – a claim that, in its detail and consistency over the years, remains troublingly credible – the campaign scrubber "You have a right to be believed" from its site. Not every survivor is equal, it turns out. (*National Review*)

BUTTS MATTER

A simple sign was put up this summer at Henderson State University [HSU] in Arkadelphia, AR. Under the school logo were the words: "The following will not be tolerated: PROFAN-ITY, EXECESSIVE LOUDNESS, RUDE BEHAVIOR, SAG-GING PANTS." For students, the "sagging pants" crackdown (ahem) was a bridge too far. As reported by KATV, Daisha Haggans of the Black Student Association declared: "The group I'm representing was outraged by the sign." Student Kristin Bell called the message "politically insensitive." Both students demanded a "diversity office" at HSU "in order for issues like this to never be a problem." The gutless suits at the school backed down, and after only two days administrators removed the sign. Apparently, wearing pants pulled below one's backside is now a civil right at college. Someday, maybe they'll champion the actual Bill of Rights. (*Limbaugh Letter*)

The Nation rose in defense of Donald Trump. <u>SCHOOLS TO PARENTS:</u> KEEP YOUR OPINIONS TO YOURSELVES

One thing parents of school-age children will hear frequently over the next couple of weeks is how badly the school wants your participation.

Don't be fooled. Trust me when I say, as a 25-year veteran school parent – my oldest started kindergarten in 1992 – that they really do not want your substantive participation.

Oh, they want certain things from you. Like your money. They definitely want that, whether for PTA or BETA club or fundraisers or sports teams or whatever. AND your time. They want that, too, to do things they'd rather not pay staff to do, like sit at the reception desk or take up tickets at ball games or shelve books in the library.

But what they definitely DO NOT want is your opinion – even when it concerns your own child. They're not interested in what you think about the curriculum or school policies or – heaven forbid – testing. You can keep those ideas, however sensible, to yourself.

That's because today's "professional educators," by and large, genuinely believe that they know more about what's best for children than you do. Not only that, but they know more about what's best for your own child than you do – and not just academically.

They think they know more about you about what your child should eat, what your child should wear, how your child should play and what your child ought to be doing when not at school (hence the excessive homework many teachers assign – and many administrators require).

If you don't believe me, just try questioning one of their policies and then listen to them struggle to keep the utter disdain for mere parents out of their voice as they babble some jargonladen non-answer answer. I've observed this time and time again, in private meetings with teachers and administrators as well as in more public settings, like PTA meetings.

I've also witnessed it at the macro level.

Several years ago, I was invited to serve on a committee of parents, community members and professional educators charged with reviewing the countywide curriculum on an annual basis – something I gather is required for accreditation by the southern Association of Colleges and Schools.

It became obvious, within the first hour of the first meeting, that the "review process" was designed to minimize actual parent participation – if, by "participation," you mean "opening your mouth."

At one point, during a break-out session to consider a specific set of objectives, I pointed out how exaggeratedly technical and jargon-riddled the documents was. The facilitating educator responded, somewhat patronizingly, "Well, any teacher could understand it."

"Perhaps," I said, "but many parents could not."

To say that he did not see my point would be an understatement. He neither understood nor cared. That curriculum document was not written for parents (or students), but for the professionals, because only their opinion really matters. And don't you forget it. Christian clergy throughout the United Kingdom should increase security at churches and take precautions for their personal safety. That's the recommendation of Nick Tolson, an official at the Home Office. One vicar has told the *Mirror Online* that authorities are urging clergy to avoid wearing clerical collars in public, although Tolson says he demurs from that particular advice. A parallel debate has arisen among observant Jews over the question of whether men should forgo wearing kippot on the streets of European cities where anti-Semitism has broken out in bloody violence or threatens to. Having largely eradicated Christianity from the Middle East, Islamists have announced in the clearest possible terms their intention to take their religious war to the West – and too many in the West have decided that the best defense is abject capitulation.
