For 50 years, the FARC has terrorized Colombia. They are Communist guerrillas, specializing in fear, torture, kidnapping, drugs, and murder. They have essentially been defeated, thanks in large part to the presidency of Alvaro Uribe, who served from 2002 to 2010. (Uribe's father, Alberto, was killed by the FARC.) Uribe's successor, Juan Manuel Santos, negotiated a peace treaty with the FARC. All that remained was ratification by the public, in a popular vote. It was expected to win in a landslide. The whole world was for it, starting with the U.N. secretary-general. But something amazing happened: It lost narrowly. The vote was 50.2 percent to 49.8 percent. Uribe had led the campaign against ratification. His side argued that the treaty was unnecessarily generous to the guerrillas. It gave them money, seats in the congress, and, essentially, amnesty. A majority of voters thought that Santos was handing the guerrillas a victory that they could not earn. Also, many simply did not trust the FARC to lay down their arms, once and for all. The desire for peace is natural and commendable in human beings. But sometimes the cost is too high. We would have voted the same way. (National Review)

FOOD AND WHINE

Some college kids are complaining about the dining hall fare. Nothing new there. But what's new is the reason. In this case, Oberlin's international students are offended by "culturally inappropriate" cafeteria food. According to The Oberlin Review, students at the far-left college find its cafeterias "insensitive" for serving "appropriative" fare. In other words, cultural theft. A freshman from Vietnam huffed that she was served a "cheap imitation" banh mi sandwich because ciabatta bread was used instead of a baguette. A Japanese student found the rice undercooked in a "disrespectful" way. The Oberlin black student union joined in with their own gastronomic outrage, as reported by The New York Post. Apparently, the food being offered at the campus Afrikan Heritage House didn't have enough vegetarian options, used too much cream, and "failed to make fried chicken a permanent feature on the Sunday night menu." NAVY BLUES

The notorious 9th Circus strikes again – and this is no fish story. The 9th Circuit Court of Appeals has ordered the U.S. Navy to nix the sonar it uses to detect subs in oceans worldwide. Why? Because the low-frequency sonar supposedly disrupts whale mating. Yep. According to *The San Francisco Chronicle*, environmentalist wacko groups claim the sonar violates the Marine Mammal Protection Act, and sued to force the navy to scale back sound levels. Seattle-area bureaucrats have been taken behind the outhouse by voters – for a crappy idea to bring in revenue. According to WeTheGoverned.com, King County, WA Council members laid a brick by floating a proposal to levy a new tax on all property owners with a septic system.
