Pursuant to the Call of the Georgia Republican Party State Executive Committee for Precinct, Rule 9.2 District, County, Congressional District, and State Mass Meetings and Conventions, the Barrow County Republican Committee hereby makes and issues this, Official Call, to all legal and qualified voters of Barrow County, Georgia, who are in accord with the principles of the Republican Party, believe in its declarations of policies and are in sympathy with its aims and purposes, to unite under this Call in the selection of Delegates and Alternates to the Barrow County Convention to be held pursuant to this Call. There shall be Election District (Precinct) Mass Meetings on March 9, 2019 at 9:00 o'clock A.M., at 354 E. Broad St., Winder, Georgia, at the Winder Lions Club, which shall elect Delegates and Alternates to the County Convention to be held on March 9, 2019, at same location. Registration begins at 8:00 o'clock A.M., on March 9, 2019. Anyone arriving after 9:00 o'clock A.M. will not be allowed to participate.

COUNTY CONVENTION

The Barrow County Convention is hereby called to convene at 354 E. Broad St., Winder, Georgia, at the Winder Lions Club on Saturday, **March 9, 2019**, at 10:00 o'clock A.M., for the purpose of electing Delegates and Alternates to the Republican Tenth U.S. Congressional District and State Conventions. Party officers for 2019-2021 will also be elected. Only those Delegates and Alternates elected in their respective Election District (Precinct) Mass Meetings held on **March 9, 2019**, shall be entitled to participate. The Convention itself shall be open to the public.

WHAT TO EXPECT AT THE 2019 PRECINCT MEETINGS AND COUNTY CONVENTION

Many of our newer members may not be aware of the significance of our upcoming Precinct Mass meetings and County Convention set for Saturday, **March 9, 2019**, at the Winder Lions Club, 354 E. Broad St., Winder. The following is information to explain what will be happening on this important date.

Temporary Precinct Meeting Chairpersons will be appointed by the current Barrow GOP Chairman Clay Kelley. At 9:00 AM on March 9, these people will call the 16 individual precinct meetings to order. All participants at these meetings must be duly registered in accordance with State Republican Party rules and Georgia State Election Code. The first order of precinct meeting business is to elect new Precinct Chairpersons for 2019-2021 (and other Precinct officers, if desired by the precinct meeting participants). The new Precinct chairperson will conduct the rest of the meeting. Each precinct meeting will then elect Delegates and Alternates to the 2019 Barrow County

Republican Convention. All Delegates will receive name tags for Convention usage.

When all of the elections are completed, the paperwork (in triplicate) will be processed and routed to the appropriate local Party representatives. Other precinct business may take place at this meeting. It will be a good time to get acquainted with other Republicans in your precinct, and plans for future precinct work can be discussed.

At 10:00 AM on **March 9**, the current local Party Chairman Clay Kelley (serving as Temporary Convention Chairman) will call the 2019 County Convention to order. After the Pledge of Allegiance, Invocation, Presentation of the State Call, and Introduction of Elected officials, the convention will elect the 2019 Permanent Convention Chairperson and Permanent Convention Secretary. Convention committees will then be dismissed to conduct their work (Credentials, Nominations, Rules). During this time, there may be announcements and speeches in the convention hall.

After the Convention committees return and report, the 2019-2021 Barrow County Republican officers will be elected. These include County Chairperson, First Vice-Chairperson, Second Vice-Chairperson, Secretary, Assistant Secretary, Treasurer, and Assistant Treasurer. The Convention will then elect Delegates and Alternates to the 10th U.S. Congressional District Republican Convention to be held on Saturday, **April 13, 2019** in Watkinsville, Georgia. Delegates and Alternates will also be elected to the State Republican Convention to be held on Friday and Saturday, **May 17-18, 2019**, in Savannah, Georgia. Those who qualify and desire will also form the new County Committee (voting members) for 2019-2021.

Your participation in the 2019 Precinct Mass Meetings will strengthen the Barrow county Republican Party. With your help, we have made a major impact. Headed for **November 3**, **2020**, the next election cycle has begun.

Meanwhile, a recent Gallup survey found Democrats preferring socialism to capitalism by ten points, with 57 percent of Democrats reporting a positive attitude toward socialism but fewer than half of them saying the same about capitalism. Some of this is what political scientists call "affective polarization," partisan embrace of ever-more-radical postures in response to the perceived wickedness of the other party, and part of it is semantics: Many young progressives think of bailouts and cronyism when they hear the word "capitalism" and of the nicer parts of Copenhagen when they hear "socialism." The opposite, and much healthier, tendency is to understand capitalism as Adam Smith, Apple, and a million lemonade stands, and socialism as what's going on in Venezuela. (National Review)

Tablet magazine reported that, at the initial meeting of the activists who ended up helming the Women's March over the last two years, two women asserted that Jewish people bore a collective responsibility for exploiting "black and brown people" and perhaps even leading the American slave trade. Later, the same women allegedly confronted one of the group's Jewish leaders with comments such as "Your people hold all the wealth." On Twitter, sociologist Gabriel Rossman made an apt allusion to Marx: Anti-Semitism turns out also to be the feminism of fools. (National Review)

In 2007, a coalition of Republicans and Democrats, farm interests and climate activists, enacted legislation that required mixing diesel fuel and gasoline with "biofuels" manufactured from plants, mainly corn and soybeans. The result: Increased global demand for farmland led tropical countries such as Indonesia to burn down forests and establish palm-tree plantations for food and fuel. This dumped massive amounts of carbon into the atmosphere and continues to do so, since the conversion process has exposed carbon-rich peat layers under the topsoil. As the New York Times reported, "the accelerated destruction of Borneo's forests contributed to the largest single-year global increase in carbon emissions in two millenniums." This result was hardly unpredictable: In 2009, in a study begun in the Bush administration, "the E.P.A. concluded that it would take 32 years before biodiesel from soybean oil was truly net-zero for carbon." But somehow, "by the time the E.P.A. released its final rule in early 2010, it had made a complete about-face. Its models now found that the impact from land-use changes" was "almost negligible." Why did this happen? The *Times* blames it all on the agriculture lobby – but somehow, in an otherwise excellent article of nearly 10,000 words, the name "Obama" appears exactly zero times. (National Review)

PLANNED PARENTHOOD MARKETING: BABY HAS "RIGHT TO DIE"

Last November, Leana Wen, a Chinese immigrant and former Baltimore city health commissioner, assumed the role of CEO of Planned Parenthood, the nation's largest abortion provider. PP is responsible for ending the lives of approximately 320,000 babies annually, and Wen is set on increasing that number.

"There is huge unmet need across our country, and it is our moral imperative to provide care for all those who need us," she said. "I plan to expand our services, and expand our reach."

Despite Wen's claims of "health care" for women, the reality is that babies' lives are being destroyed, and marketing for abortion grows more and more diabolical. One example is "The Chosen," a disturbing 40-second video by the Agenda Project. "The Chosen" features a wide-eyed baby girl who smiles and coos, interrupted by intermittent black screens with the words, "She deserves to be loved," "She deserves to be wanted," and finally, "She deserves to be a choice."

America's retirement system is frequently said to be in crisis, with most of the blame going to the shift to 401(k)s. It's a case that rests on the distortions of nostalgia and ignores the evidence that retirees are doing better than ever and retirement saving is higher than ever. Among the actual flaws of our system is that 401(k)s are not accessible to all who could make good use of them. The Trump administration is trying to fix that by letting groups of small employers who cannot afford to administer their own plans band together to offer tax advantaged savings vehicles for their employees. Whether the administration has the legal authority to make this change on its own is debatable. Congress should act to make the legal issue moot. (National Review)

Once Upon A MeToo

Actress Kristen Bell, the voice of Princess Anna in the Disney cartoon "Frozen," is inserting the #MeToo movement into ancient fairytales. Bell told *Parents* magazine that after reading "Snow White" to her two little girls, she asked them, "Don't you think it's weird that the prince kisses Snow White without her permission? Because you cannot kiss someone if they're sleeping."

Wow, way to "woke" up bedtime stories.

But here's what's really Dopey: expecting a spell-paralyzed fairytale character to give "permission" to another fairytale character. Apparently, to make liberals Happy, the makebelieve prince should just let the Sleepy Snow White live unhappily ever after, alone – and comatose.

In any event, you'd think this consent issue would be dwarfed by Ms. White's harassment risk from living with seven little men. Not to mention the risk that PC-raised kids could become Bashful at any male Doc performing CPR or the Heimlich maneuver. But is anyone shocked that a Grumpy left-wing actress's storybook lacks common sense? Let it go.

Marc Lamont Hill has said terrible, anti-Semitic things. He has called for the destruction of the state of Israel. He has paid tribute to Louis Farrakhan. He has lamented Israel's "Iron Dome" missile-defense system because it takes away Hamas's "military leverage." But he is of course still an American citizen and enjoys all of the protections of the first Amendment. That's why Temple University was right not to take action to punish him for his speech. Temple, after all, is a public university bound by law to protect his free-speech rights. And that's why it was wrong for outraged members of the public to call for Hill's termination. The feeling of outrage itself, on the other hand, has our endorsement. (*National Review*)

SANCTUARY CITIES RULLED UNCONSTITUTIONAL

In late September, California Superior Court Judge James Crandall in Orange County ruled that Senate Bill 54, also known as the sanctuary state law, is unconstitutional. SB54 was signed into law by Governor Jerry brown in October 2017 and basically made the entire state of California a safe haven for illegal immigration.

Several California cities and counties quickly voiced opposetion to the law, with some even drafting ordinances to opt out of the state-level sanctuary law. Other cities, such as Huntington Beach, filed suit against the state, claiming that SB54 infringed on local governmental authority. The Superior Court judge agreed with Huntington Beach and ruled that, according to California's constitution, the city had a right to police itself.

Despite the judge's ruling, State Attorney General Xavier Becerra stated that California would simply continue to uphold its sanctuary law. (latimes.com, 9/28/18; cnbc.com, 9/29/18; townhall.com, 9/30/18. *AFA Journal*)
